REQUEST FOR RELIEF

WHEREFORE, I REQUEST:

1. That the court enter a *Final Order* that disestablishes Defendant 2 as the legal father of the minor child(ren) in question and terminates any rights of custody or visitation;

2. That the court enter a *Final Order* that establishes Plaintiff as legal/biological father of the minor child(ren) in question;

3. That the Bureau of Vital Statistics be given notice to replace Defendant 2 with Plaintiff on the birth certificate(s) of the minor child(ren).

4. That the court enter a *Final Order* that relieves Defendant 2 of any ongoing child support obligation from the date I filed this *Complaint*;

5. That arrearages be modified as allowed by law.

NOTE: *The general rule is that child support cannot be retroactively modified. This means the court cannot go back and change past due child support amounts. However, depending on how the original obligation was established, the court may be able to set aside some or all of the arrearages. This is a complicated area of law and you should consult an attorney to find out whether something can be done in your case.*
