1. If both spouses agree:

- to end the marriage
- that there is no property or debts to divide, AND
- the wife is pregnant by a man who is not the husband so want to disestablish paternity of the husband after the child is born

Optional Forms Depending on the Situation

SHC-1342 Word PDF	Joint Motion, Affidavit & Order to Appear and Testify By Telephone	1 Motion & Affidavit form from both parties DO NOT sign the Order
SHC 153 Word PDF	Joint Motion, Affidavit & Order to Bifurcate for Paternity (<i>this form asks the court to grant the divorce before the baby is born and disestablish the paternity after the birth</i>)	1 form signed by wife, husband and notarized on page 2; on page 3, fill out everything on the proposed Order except do not fill anything out below "IT IS SO ORDERED."
SHC-151 Word PDF	Three-Way Affidavit of Paternity (for the court to consider after the baby is born)	1 form signed by wife, husband and biological father

Information Required by the Judge

- Tax return, most recent unless judge asks for more
 - Current pay stubs for last 2 months
 - If you are disestablishing paternity, after the child is born you must show clear and convincing evidence to the Judge that you are not the parent. For example:
 - DNA testing results
 - Three-Way Affidavit of Paternity, SHC-151 [Word](#) | [PDF](#), signed by wife, husband and biological father
2. Make 2 copies of all filled-out forms and save for each spouse's records.
 3. File the filled-out and signed forms at the court. A court employee can notarize the affidavits for free.
 4. The court will give you a Domestic Relations Procedural Order when you file. This document is the first Order from the judge. Please read it carefully.
 5. Wait for the judge to schedule a hearing. You will be notified by mail of the date.
