

IN THE SUPREME COURT OF THE STATE OF ALASKA
ORDER NO. 2015

Amending Minor Offense Rule 17(h) and adding a Note to implement the direct court rule amendment made by Chapter 8 SLA 2022 (SB 9);

Amending Administrative Rule 40(a)(14) to remove from CourtView an underage alcohol offense enacted in Chapter 8 SLA 2022 (SB 9);

Amending Administrative Rule 43.5 alcohol bail forfeiture schedule to include minor offense violations enacted in Chapter 8 SLA 2022 (SB 9) and failure to post warning signs offense; and

Rescinding Administrative Rule 43.7 warning signs bail forfeiture schedule.

IT IS ORDERED:

1. Minor Offense Rule 17(h) is amended to read as follows:

Rule 17. Minor Offenses in Criminal Cases.

* * * *

(h) **Joinder Limits.** A prosecutor may not join a violation of AS 04.16.049, ~~or 04.16.050,~~ or 04.16.060(g) or a similar municipal ordinance with a related criminal charge.

2. The following note is added to the end of Minor Offense Rule 17:

Note: Chapter 8, SLA 2022 (SB 9) enacted comprehensive changes to Alaska’s alcohol licensing and enforcement laws. Section 163 of the Act amended subsection (h) to add AS 04.16.060(g) as another underage offense that may not be joined with a related criminal charge. This rule change is adopted for the sole reason that the legislature has mandated the amendment.

3. Administrative Rule 40(a)(14) is amended to read as follows:

Rule 40. Index to Cases.

(a) The court system shall maintain an index by last name of every party named in every case filed, regardless of whether a party’s true name is protected in the public index under paragraphs (b) or (c) of this rule. The index must show the party’s name, the case number, the case caption or title, the filing date, the case type, and other information required for that case type by court rule. The index may show the party’s date of birth. The index shall be an accurate chronological record of the case’s filings and events as they actually occurred in the case. If subsequent case filings amend or purport to correct a prior filing or event, the existence of the initial filing or event having occurred shall be maintained along with the amended filing, so that the index is at all times a record of actual filings and events in the case. The court system shall publish a public version of the index on the court system’s website, which excludes only

(14) cases in which the defendant was charged with an offense under AS 04.16.049, 04.16.050, 04.16.060(g), 28.35.280, 28.35.285, 28.35.290, or a similar municipal ordinance (whether

the case was classified as a criminal case, minor offense case, or underage alcohol case and regardless of the disposition of the case), if the offense was charged in a separate action and not joined with any other minor offense or criminal charge at the time of filing; and

4. Administrative Rule 43.5 is amended to read as follows:

Rule 43.5. Alcohol Bail Forfeiture Schedule.

Pursuant to AS 04.16.205(c), AS 04.21.065(g), and AS 04.21.074, the following offenses may be disposed of without court appearance upon payment and forfeiture of the bail amounts listed~~bail forfeiture amount is established for violation of AS 04.11.501 or an ordinance adopted under this statute.~~ If a person charged with one of these offenses ~~this offense~~ appears in court and is convicted, the penalty imposed for the a first or second offense, except for third or more offenses under AS 04.11.501 or an ordinance adopted under this statute, may not exceed the bail amount listed below in addition to any forfeiture required by statute.
